#### 214/13 Budget Position

The Lead Officer presented the finance report. There were two large funded projects which affected the probable outturn for the year. The details of these projects and the effect on the budget were explained to Members.

Members discussed the information received from Durham County Council on Medium Term Financial Planning and 2014/15 budget setting. The information received indicates that the Local Council Tax Support Scheme Grant received from the County Council this year is likely to be reduced over the next few years. Members considered the budget and precept setting timescales for 2014/15.
