266/14 Public Participation

The public participation policy was distributed for the benefit of the public present.

267/14 Budget Position

The Lead Officer presented the finance report. **Recommended -** that the report be received

268/14 Memorial Plaque – First World War

Members were informed that the Memorial Plaque previously displayed at Park House needed to be relocated.

Aubrey O' Brien a local resident had undertaken the task of cleaning and polishing the plaque. Aubrey attended the meeting. He informed Members that research shows that the Memorial Plaque was originally located in the old picture house and then at the council offices. He states that there are other listed war memorials that people should be aware of. He would be disappointed if the plaque was in a location where it could not be widely viewed by the community.

It was agreed that the Memorial Plaque needed to be housed indoors and in a location where the community could view it. **Recommended -** that an approach is made to Lanchester Community Centre to display the memorial plaque

273/14 Budgets 2014/15 and 2015/16

The Lead Officer presented the budget report.

Members were informed that a national pay award had now been agreed. The Handyperson is employed on the equivalent hourly rate of SCP 7. The National Pay Award included the following elements:

• New pay scales to be introduced from 1 January 2015 (not back dated)

Clerk SCP 34 - £29,558.00 (FTE) – 2.2% pay award Handyperson SCP 7 - £7.128 (hourly) – 6.2% pay award

• A one-off payment to be made in December Clerk SCP 34 - £100.00 (FTE)

Handyperson – SCP 7 - £325.00 (FTE)

• A further one-off payment to be made in April Clerk SCP 34 - £33.00 (FTE)

Recommended - that the National Pay Award is applied to both staff

Members discussed the proposed Durham Living Wage and the Clerks hours

Recommended that:

- (i) The clerks hours are increased from 23 to 24 hours per week from 1 April 2015
- (ii) The hourly rate of the Handyperson is increased to reflect the proposed Durham Living Wage of £7.43 per hour from 1 January 2015

Members discussed the garage rents.

Recommended - that the garage rents are increased from $\pounds 45.00$ to $\pounds 50.00$

The proposed budget for 2015/16 was considered.

Recommended - that the budget is agreed subject to inclusion of the above decisions
