## 32/13 Police Report and Neighbourhood Warden Report

PCSO Lisa Jackson attended the meeting and presented the police report which gave information regarding incidents / crimes in the area for the period 28/11/12 – 21/01/13 as follows:

## Dwelling Burglaries

# 35/13 Grassed Area – Lanchester Valley Railway Path – between Station Road and Newbiggen Lane (min 276/12)

The Chair gave the background to this item in that the County Council have stopped cutting the grass in this area which they own and have approached the Parish Council to ask if the Parish Council would wish to take over responsibility.

Following discussion at a previous council meeting, information had been sought from the County Council on maintenance and liability issues particularly in relation to the burn, culvert and trees in this area.

The response from the County Council to these enquiries was reported and discussed. Members discussed concerns they had regarding taking on ownership and responsibility for this area including the potential legal costs that may be incurred.

A number of residents attended the meeting and spoke and also raised a number of concerns and issues

A discussion took place on whether the parish Council could cut the grass if the land remained in County Council ownership.

**Resolved -** that the County Council be approached to consider whether a formal agreement could be put in place which would mean that the County Council would retain ownership, management and liability for this area and which would allow the Parish Council to cut the grass.

The Government as part of the Localism Act 2011 introduced a new 'General Power of Competence' for local councils. The Power gives eligible local councils 'the power to do anything that individuals generally may do' providing it is within the law. In order to adopt the Power, Councils need to demonstrate that they fulfil the criterion which includes:

(i) having a qualified Clerk

(ii) the number of Councillors elected at the last election or at a subsequent by-election must equal or exceed % of the total number of seats on the council

Members considered adopting the General Power of Competence.

**Resolved -** that Lanchester Parish Council meets the criteria for the General Power of Competence and adopts the Power
