271/11 Lanchester Community Orchard and Allotments – Lanchester Partnership

The Chair welcomed Sonny Shepherd to the meeting who gave an update on the progress of the Community Orchard and Allotments. A proposed plan of the site was distributed to Members. The design of the development shows that the orchard surrounds the plot with the allotments in the middle.

The orchard costs £10 per year and members of the scheme are expected to contribute some work on the site and may then take away a share of the produce. There are 30 families interested in being involved.

The allotments which measure 10m by 10m cost £1 per week and will be run on a not for profit basis. There are 38 interested people.

The Chair thanked Sonny for attending and updating the Council on progress and congratulated the Partnership on the progress of the project.
