158/13 Lanchester Flood Report

The Chair welcomed Paul Armin the Senior Drainage Engineer from Durham County Council to the meeting.

Paul presented an initial report that had been compiled to look at the flooding issues mainly in Front Street and at the junction of Maiden Law Bank with the A691.

The report identifies the following problems:

- the interaction between the culvert of Smallhope Burn and the culvert of Alderdene Burn
- surface water on Newbiggen Lane
- blocked culvert on Maiden Law Bank

Consideration is being given to diverting the Alderdene culvert to further down Smallhope Burn and a bid has been submitted to the Environment Agency for up to £1.2milllion to undertake the works.

The application needs to be approved by the national committee in December, following which a detailed / modelling study will be carried out. This will demonstrate the effect of the works and identify any additional works or issues.

The earliest start date would be April 2015.

Paul informed Members that the County Council has made 25 applications to the Environment Agency and that Lanchester is a top priority.

Paul asked that councillors and members of the public report blocked gullies to the County Council for action.

The Chair thanked Paul for attending the meeting.
