### 60/11 Declarations of Interest

### 61/11 Public Participation

### 62/11 Planning Applications

Members considered the following planning applications:

(i) Application to vary Condition 3 of Planning Permission 1/2006/0243 to enable part of garage, stable and storage building to be used as a residential annex with external alterations (Resubmission) at Woodlea Manor, Browney Bank, Lanchester 1/2011/0035

Members discussed the application.

#### Resolved that:

- (i) members object to the application as a detached residential development in the open countryside
- (ii) members consider that Condition 3 of planning permission 1/2006/0243 should remain in place

Members also stated that if approval was to be given to the development that a condition on the approval be made to state

that it can only be used as an annex to the main dwelling and not as a separate residential dwelling

# (ii) Change of use from police station to wedding car hire business and extension of existing garage and creation of pitched roof to former Police Station, Millfield, Lanchester 1/2011/0042

Members considered the application and raised various concerns

## Resolved that members object to this development and raise the following issues:

- (i) members note that the development is within / adjacent to the designated conservation area / article iv area which requires sensitive consideration
- (ii) members consider this to be a significant commercial development in a residential area
- (iii) there is concern of the access and egress to the site and of vehicle movement within the area
- (iv) this is a congested location next to a church and schools
- (v) there is concern about disruption for current residents

## (iii) Agricultural Determination for the erection of a silage pit and creation of new access road at Greenwell Farm, Lanchester 1/2011/0036

Members considered the application and raised various concerns, including public right of way, highway issues and concerns around the silage tank.

**Resolved -** that members object to this development.

A member of the planning committee has done extensive research on this application and it was agreed that these notes form the basis of the response.

## (iv) Felling of one silver birch tree (section 211 notice) at White Leas, Crow Hall, Lanchester 1/2011/0065

**Resolved -** that members raise no objection to the application but request that the felled tree be replaced with a suitable alternative

### (v) Conservatory to rear at Foxhills Crescent, Lanchester 1/2011/0079

**Resolved -** that members raise no objection to the application
