# 204/15 Declaration of Interest

# 205/15 Public Participation

## 206/15 Budget Position

## 207/15 Neighbourhood Plan (min 195/15)

Members were informed that work continues with the Neighbourhood Plan.

Work on the Conservation Area Appraisal has commenced and is being co-ordinated by the County Council. Four sessions have been organised in October to survey the conservation area. Volunteers are welcome to take part.

The North of England Civic Trust have been appointed to assist the community in producing a Heritage Audit for the Parish. Work on this is likely to commence in November. The third and final workshop has been delivered by Neighbourhood Plan-It. A draft topic based questionnaire has been prepared and discussed.

Work continues on gathering evidence and profile information.

# 208/15 Garage Door Replacement

The replacement of the broken garage door was discussed. It was agreed that the opening should be partly walled with a door at one side.

# 209/15 Local Council Award Scheme

Members were informed that the new Local Council Award Scheme was now in operation which replaces 'Quality Status'. As a current holder of Quality Status, Lanchester Parish Council had been offered and had taken up a free Foundation year in the new scheme which will expire shortly.

The Parish Council has registered in the scheme at a cost of  $\pounds 50.00$ , a further small fee will be due on submission

- (ii) a submission is made for 'Foundation' stage when all the criteria has been met

# 210/15 Website

#### 214/15 Planning Application

Members considered the following planning application:

Removal of condition 4 of planning permission 1/2011/0035 to permit the use of the residential annex as a dwelling (use Class C3) at Woodlea Manor, Lanchester DM/15/02672/VOC

When permission was given in 2011 for the residential annex the Parish Council wrote to Durham County Council and stated:

'If approval was to be given to the development that a condition on the approval be made to state that it can only be used as an annex to the main dwelling and not as a separate residential dwelling' Members ask that this condition remain.

**Recommended** – that the parish Council object to the removal of condition 4.
