216/16 Public Participation

217/16 Budget Position

The Lead Officer presented the finance report. **Recommended -** that the report be received

218/16 Kitswell Park Football Pitch

Members considered correspondence received from the Ashdown Grove Neighbourhood Watch Co-ordinator which outlined concerns of residents about inappropriate language of footballers and spectators, trespassing on private property and littering.

Representatives from the football club attended the meeting and spoke. They were not aware that these problems had arisen and state that there is not a history of problems with residents.

The representatives from the football club confirmed the following:

- (i) Players will be told not to enter gardens without permission.
- (ii) Home and away players and spectators are to be made aware of residents concerns

- (iii) Players and spectators will be told to pick up litter and dispose of it appropriately
- (iv) The referee should address any bad language from players
- (v) The football club will deliver leaflets to houses stating that they are addressing concerns and including a contact number

The Parish Council confirmed their support for the football club and look forward to the issues being resolved.

The Parish Council expressed concern about several gate entries from houses onto Kitswell Park. There are four official entrances into the park which include: Victoria Terrace, Fenhall Park, cricket club main entrance through the car park and the car park entrance to the bike track.

- (i) A copy of the letter from the Neighbourhood Watch Co-ordinator is sent to the cricket club for their information
- (ii) A letter is sent to the Neighbourhood Watch co-ordinator outlining the actions agreed
- (iii) A letter is sent to the football club thanking them for attending the meeting and confirming the agreed actions
