1. Welcome

4. Notes from the last meeting

5. Housing Topic Paper

Shaun Hanson attended the meeting and presented the Housing Topic Paper (Topic Paper attached) (Presentation slides attached)

6. Historic Environment Topic Paper

It may be that once the County Durham Plan Preferred Options Paper is received that not all the objectives need to be progressed.

It was agreed to discuss the remaining topic papers at the next meeting.

8. Heritage Audit

The group considered the previously circulated report and gazetteer.

It was agreed to circulate the documents again to all members for final comments. Following final amendments the Parish Council would receive: paper copies, pdfs and word and excel versions of the documents to accommodate future amendments.
