

Lanchester Neighbourhood Plan

About the Neighbourhood Plan

The Neighbourhood Plan is a new kind of planning document being prepared by the Parish Council on behalf of the community. Once completed, it will have legal status and be used in making decisions on planning applications within the Parish.

The preparation of the Plan provides the opportunity for everyone in the local community to decide how our area should grow and develop in the future in four key ways -

- BY PROTECTING the things people cherish within the area
- **BY IMPROVING** the things which detract from its appeal
- **BY PROVIDING** for development and uses of land to best meet the needs and aspirations of those living, working in and visiting the Parish
- BY MANAGING the aspects of development and land use which need to be carefully managed

Moving forward - we need your views!

The Parish Council's Neighbourhood Plan Group are keen to seek your views to help us move forward with the development of the Neighbourhood Plan.

Since we carried out our early engagement consultation at the beginning of 2015, we have been busy assessing what you said. As a result, we have now developed a draft vision and objectives under 7 key topic areas to help form the building blocks of the Neighbourhood Plan. We think these capture the key messages from the early engagement, but we'd like to hear what you think before moving forward.

Together with the draft vision and objectives, we are also asking a few more focussed questions under each topic. Your responses will help make sure we have all the information and support we need to develop the detailed subject matter of the Neighbourhood Plan.

Completing and returning the questionnaire





A) A SHARED VISION FOR THE FUTURE OF LANCHESTER

The preparation of a Neighbourhood Plan for Lanchester gives everyone the opportunity to have a say in what our Parish should be like in the future (the next 10 to 15 years). Your responses to the earlier consultation revealed some clear and recurring messages and we have drawn these together to set out a draft vision for the Neighbourhood Plan.

We would like to begin this questionnaire by seeking your views on the draft vision to make sure that it properly captures the aspirations of the community and is broadly supported:

DRAFT VISION:

'Lanchester will be a place with the facilities and amenities to serve and maintain a strong and cohesive community. The Neighbourhood Plan will protect and enhance its essential village character, its wealth of diverse wildlife habitats and heritage assets, its attractive rural setting and the economic, social and leisure opportunities they provide to the benefit of all who live, work in and visit the area'.

B) HOUSING

A Neighbourhood Plan is used to guide and manage new development, not to stop it entirely. In terms of housing development, we need to ensure that the Plan strikes the right balance – planning appropriately for the future housing needs and aspirations of the local community, whilst at the same time safeguarding the essential character and identity of the village and the Parish.

The earlier consultation identified that pressure for new housing development was a dominant concern. However, at the same time, there was a clear recognition that, for the community to flourish, housing needs ought to be appropriately and sensitively addressed, with particular reference to homes for the elderly and affordable homes. This section includes some questions to help us better understand your views in relation to housing needs and the best way of accommodating them.

As an alternative to conventional 'developer-led' housing, the Neighbourhood Plan could put forward measures to facilitate custom or self-build homes. The previous approach in the Local Plans of many former District Councils in County Durham was to identify **settlement boundaries** (known as 'development limits') as a mechanism to manage the location of new development. Map 2 on p.2 shows the boundaries established for Lanchester under the former Derwentside Council's Local Plan. This approach is not however being pursued in the Council's new County-wide Local Plan.

The Neighbourhood Plan however provides an opportunity to consider whether a boundary should be identified around Lanchester, and if so, how should it best be drawn in terms of providing appropriate scope for new development.



C) DESIGN OF NEW DEVELOPMENT

The Government attaches great importance to the design of the built environment, especially design that will help establish a 'strong sense of place' and 'create attractive and comfortable places to live, work and visit'.

Some of the key messages from the earlier consultation around design issues included a desire to achieve improvements in the design of housing, the importance of having attractive buildings in the village centre and the need for building conversions to be sympathetically carried out.

In the light of the above, the following broad objective has been prepared which seeks to capture the overall approach that the Plan would take in respect of the design of new development:

DRAFT OBJECTIVE 2: DESIGN OF NEW DEVELOPMENT

'To ensure that any new development in the Parish, whether it is new-build housing, conversion of existing buildings or other built development is carefully designed to protect the essential qualities and attributes of the area'

The Parish has previously prepared a Village Design Statement for Lanchester, recognising the features and aspects of design that make up the essential character of the area. D) BUSINESS & EMPLOYMENT

It is important to ensure that the right kind of support is given to businesses to survive and grow in the Parish. E) HISTORIC ENVIRONMENT

The heritage of the Parish is one of our greatest assets. The results of earlier consultation were clear that the community wanted it to be properly identified, cherished and protected for current and future generations. We already have a Conservation Area for Lanchester, which is designated for its special architectural and historic interest. We also have the Longovicium Roman Fort site and other Scheduled Ancient Monuments as well as a large number of Listed Buildings.

In the light of the above, the following broad objective has been prepared which seeks to capture the overall approach that the Plan would take in respect of conservation and heritage:

'To ensure that the diverse heritage assets of the Parish are identified, protected and enhanced, and their significance is understood, recognising the positive role they can have in learning for present and future generations and the economic, social and leisure value they provide to those who live, work in and visit the area'

The Parish is currently working with the County Council to carry out an appraisal of the Conservation Area, and with the North of England Civic Trust to carry out a comprehensive audit of the heritage assets of the Parish.

The Conservation Area (and wider Parish) contains a number of Listed Buildings, which are buildings or features identified on the National Heritage List held by Historic England. These are protected by law and require Listed Building Consent to extend, alter or demolish them.

However, there may be other historic buildings, features or sites in the Parish, which, although locally important, do not have the protection of being Listed Buildings. These could include anything from historic landscapes or areas (including below-ground archaeology) to characterful buildings and structures and smaller features such as historic stiles, milestones, post boxes or signs etc.

The preparation of a Neighbourhood Plan offers the opportunity for these to be identified on a 'local list', which would enable them to be afforded some degree of recognition and preservation.

Responses to the earlier consultation showed that the local community also valued the attractive rural setting of Lanchester, its open green spaces, trees and wildlife and the quality of the wider countryside.


