# 107/18 Planning Applications

 Demolition of existing two storey rear extension, erection of new rear extension with rooflights, single storey front extension and insertion of new window opening at first floor level to front elevation at 4 Percy Place, Lanchester DM/18/00304/FPA

Members considered the application. It was noted that this application is within the Conservation Area and Article IV area. Members considered that the application proposed a sympathetic extension to the property.

Residents attended the meeting and spoke about the application.

#### **Recommended that:**

- (i) The Parish Council supports the application
- (ii) The Parish Council ask that the County Council ensure that the design is in keeping with the Conservation Area and Article IV area

(ii) Reconfiguration of the exit from St Bedes Catholic School and Sixth Form College onto the A691 to provide additional lanes at St Bedes Catholic School and College, Lanchester DM/18/01023/FPA

Members considered the application which was an amended plan from a previously approved application. Members considered this to be an improved proposal. Members welcomed the application which attempts to improve the current situation.

(iii) Demolish existing steel and timber framed buildings and erect a steel portal framed livestock building to provide suitable housing for calf rearing on land to the North West of 1 Hurbuck Cottages, Lanchester DM/18/00982/FPA
