# Neighbourhood Plan Working Group

## 1. Welcome

Mike Wardle welcomed everyone to the meeting. Mike informed the group that very sadly, Councillor Ann Cooks husband Michael, had recently passed away.

## 2. Apologies for Absence

Apologies were received from Terry Coult, Elaine Hogg and Stuart Carter.

## 3. Declarations of Interest

There were no declarations of interest.

## 4. Notes from the last meeting

## 5. Lanchester Neighbourhood Plan – Draft Document

The third draft of the Neighbourhood Plan document had been distributed electronically to members prior to the meeting. Hard copies of the draft document were available at the meeting.

The following comments were raised:

- It was clarified that there will be an executive summary in the Neighbourhood Plan document. In addition a summary document will be produced to be distributed to the community as part of the consultation on the plan.
- Page 2 take out wording *'the benefits include ...... voting to approve it'.* However this wording will remain in the summary document distributed to the community.
- Page 6 add 'Flooding' section in contents page

- Page 6 Take out 'Community Asset' from statements
- Page 8 Change dates to '2019 2034'
- Page 11 Check Dere Street photo with LNP4
- Page 11 take out wording 'there is little surviving ..... links to Old English'
- Page 12 rewording of the end of paragraph three
- Page 16 additional wording to be added between paragraphs one and two
- Page 16 take out word 'discreet' from paragraph two
- Page 19 slight rewording at end of paragraph six
- Page 21 insert word 'Parish' in paragraph three
- Page 27 additional wording in last paragraph
- Add Derwentside Local Plan to the glossary
- A number of suggestions had been received from the Design Sub Group. It was agreed to circulate these to the group for comment.
- The design group had suggested that a description of the settlement edge taken from the Village Design Statement is included within LNP1. Following discussion it was agreed that this information should stay within the Lanchester Design Statement with possibly some rewording.

- Page 38 Change '*special*' to '*important*' on second line. Maybe add additional words here.
- Page 38 possibly change 'Lanchester Village Framework' photo

- Page 44 check whether '*Local List*' is correct with Durham County Council
- All policies to include the % support from community consultation to the objectives
- Page 13 check 'Black Plantation' management
- Page 48 strengthen information on 'Landscape Appraisal'
- Page 48 LNP4A take out word 'only'
- Page 48 LNP4A take out word 'and'
- Page 48 take out word 'as such'
- Page 49 add words 'stone walls' to LNP4C retention policy
- Page 53 & 54 take out empty column and bold the heading 'Policy Area'
- Page 55 take out words 'ideally look to'
- Page 57 change 'Village' to 'Lanchester'
- Page 58 small changes to glossary
