241/19 Police Report

The Police report for October was read out which included the following incidents:

- 1 x Anti-Social Behaviour Ford Road, Lanchester report of 3 youths throwing a wheelie bin into the road
- 1 x vehicle crime West Drive, Lanchester damage caused to the rear windscreen
- 3 x thefts. 1 of diesel from petrol station. 1 from Three Horse Shoes at Maiden Law where several items had been stolen. 1 from Hall Hill Farm where a tractor battery was stolen.
- 1 x criminal damage which occurred at The Paddock, Lanchester relating to damage of a diesel bowser.
- 1 x burglary at The Paddock, Lanchester where a total station machine was stolen.

At present the main issue in the area relates to off road bikes riding around the Lanchester/Burnhope area. The Police would ask anyone with information to ring the 101 number so officers can tackle the matter.

242/19 Traffic Issues at Hollinside

Members considered the concern of residents regarding the speed limit at Hollinside. The current speed limit past Hollinside is 60mph.

A resident from Hollinside attended the meeting.

Members were informed that the County Council Highways section and the Police had already been contacted, however they indicated that they would not wish to reduce the speed limit. The Police have agreed to undertake a speed survey, the last survey being in 2014 which showed an average vehicle speed of 43mph.

Members considered that since 2014 the volume and speed of traffic may have changed along with the demographic of the residents of Hollinside and neighbouring properties. A resident spoke and outlined the following concerns of Hollinside residents:

- Change in demographics of the Hollinside population. There are children including 5 under the age of 5 years.
- There is a play area at one end of Hollinside Terrace which children go to and from
- There are elderly residents some with reduced mobility. Some are reluctant to use their cars which requires turning onto and off the main road with a 60mph speed limit
- Increased level of HGV's from nearby businesses
- There have been 5 road traffic accidents in the last 7 years no significant injuries
- The residents are compiling their own risk assessment
- The residents would be grateful for any support in this matter

Resolved that:

- (i) A letter is sent to the County Council and Police supporting a new speed survey at Hollinside
- (ii) A site visit is arranged with Councillors and the Police and County Council Highways

249/19 Works on Village Green (min 219/19)

Following the last meeting communication has taken place with Northumbrian Water Ltd. It is Northumbrian Water Ltd who will be undertaking the works on the Village Green not the individual resident.

Northumbrian Water Ltd intend to upgrade the water main by replacing the existing 35mm pipe with a 63mm pipe to serve a number of properties. The pipe will run from the front of the Blacksmiths Cottage to The Lodge. Northumbrian Water Ltd have served the Parish Council with a Notice of Intent to undertake the works.

A site meeting took place on 28 October between the Parish Council, Northumbrian Water and Fastflow. Northumbrian Water Ltd will be responsible for the works including: traffic management, informing nearby residents, Health & Safety, scanning for pipes and other utilities, trial holes, heritage scan and maintenance.
