219/19 Correspondence

(i) Request from resident – works on the Village Green

Members considered a request and information received from a resident regarding digging a trench on part of the Village Green to access water supply.

Members were informed of correspondence received from a resident asking that a pipe be laid across part of the Village Green to enable the resident to access a water supply for their newly built property. The route of the pipe proposed would be from the entrance of The Lodge to a Northumbrian Water connection point in front of the Old Blacksmiths Shop an area which is Village Green. The work would be undertaken by a contractor appointed by the resident.

The law and rules appertaining to Village Greens are complex.

Members were reminded of their responsibilities as set out in section 12 of the Inclosure Act 1857 and section 29 of the Commons Act 1876.

If permission were to be granted to allow the works to be undertaken then a wayleave / easement would need to be drawn up which would require legal advice.

A lengthy discussion took place regarding the matter.

A member of the public attended the meeting and informed Members that the proposed route had been provided by Northumbrian Water Ltd. The pipe would be laid using a directional drilling method which would provide minimal disturbance to the ground. The property already has other services including electricity and gas.

Members considered the following matters:

- Whether the Parish Council have the legal right to give permission for the works
- How deep would the trench be
- Is there an alternative route which does not necessitate the need to go over the Village Green
- The need for more technical information on the proposed route and works including information on the directional drilling method
- Noting that this is a historic area and the concern of disturbing heritage assets
- The need to safeguard and protect the Village Green
- The need for legal advice if a wayleave were to be progressed and the costs this could generate. The need to clearly identify who would be responsible for future maintenance

Members felt that they needed more information before a decision could be made. It was necessary to ensure that any decision safeguarded the interests of the Village Green.

Resolved that the following is agreed:

(i) Further advice is sought on legal aspects

- (ii) Further technical information is requested on the proposed route and works
- (iii) A letter is sent to Northumbrian Water Ltd requesting that they consider any alternative routes given the status of a Village Green
- (iv) A site visit is organised with the resident, contractor and the Parish Council

(ii) County Durham and Cleveland County Training Partnership – Chairmanship Training Course
