275/19 Pilgrimage Routes – Way of Light (min 228/19)

David Pott, Pilgrimage Routes Coordinator for Northern Saints Trails attended the meeting and presented information on the new Pilgrimage Routes.

Four new Pilgrimage Routes have been established in County Durham where previously there had been no routes. The new routes aim to increase visitor numbers and provide new opportunities for Pilgrimage Routes in the North East of England. A wide variety of partners have been involved in the project which will create a major European pilgrimage destination. The routes will open in Spring/Summer 2020.

One of the new routes, 'The Way of Light' will pass through Lanchester on its way from Heavenfield to Durham a distance of 45 miles.

The first pilgrimage of 'The Way of Light' is planned between 28 – 31 May 2020.

Work is currently being undertaken on marking the routes and producing a guide book and website details.

276/19 Northumbrian Water Ltd – Sewer System (244/19)

Clair Richardson from Northumbrian Water Ltd attended the meeting.

Clair provided an update on activities in Lanchester and presented information on the investigation surveys, hydraulic modelling and flood mitigation measures.

A survey had taken place with a number of properties to ascertain the experience of flooding.

Northumbrian Water Ltd can address flooding problems by either looking at larger scale engineering works or by addressing problems at individual properties.

Any larger scale schemes need to be costed up and ranked in order of priority and consulted with the public. They need to be sure that the

scheme is assessed against other schemes and the money is spent in the right places.

Members discussed the information presented including the complex detail of some of the information.

It was suggested that a written report attached to the agenda would be useful for Members to receive in advance of the Parish Council meeting.
