An amendment was proposed by Councillor Jude Considine seconded by Councillor David Smith for a 2% increase in precept.

Members voted on the amendment which resulted in 5 votes for and 5 votes against. The Chair voted against the amendment.

Members voted on the original proposal for a 4% increase which resulted in 6 votes for and 5 votes against

Resolved - that the precept be set at £67,943.06 for 2021/22

This would result in an increase in band D council tax to £45.89 (an increase of £1.65 a year or 3.73%)
