92/21 Public Participation

## 93/21 Minutes of the last meeting

## 94/21 Co-option to the Parish Council

Resolved - that under the powers contained in Section 100A of the Local Government Act 1972 the Press and Public be excluded from the following item of business as publicity would be prejudicial to the public interest because of the confidential nature of the business to be transacted

Councillors considered the eligibility form and statement provided by a resident wishing to be considered for co-option to the Parish Council. It was confirmed that the candidate fulfilled the eligibility criteria.

**Resolved -** that Eric Hepplewhite is co-opted onto Lanchester Parish Council

Eric Hepplewhite signed his Declaration of Acceptance of Office and received his induction pack.

#### 95/21 Correspondence

(i) Letter from resident – Woodlands – subsidence problems Councillors considered a letter received from a resident in Woodlands regarding subsidence to their property which they believe is caused by nearby trees.
Received – thet a letter is cont to the County Council acking them to

**Resolved -** that a letter is sent to the County Council asking them to investigate the problem and the residents are informed accordingly

(ii) Letter from resident – concerns of recent road traffic accidents Councillors considered the letter received and acknowledged that more accidents occur than just the reported ones. It was noted that works to the Kings Head junction had taken place in recent years to address the number of road traffic accidents. Resolved - that the letter is passed to the County Council

(iii) County Durham Association of Local Councils (CDALC)

(iv) Lanchester Partnership – request to put banner on the Village

(v) Information from resident – Parish boundary Councillors considered information received regarding suggested changes to the Parish boundary. The County Council are responsible for Community Governance Reviews. The initial opinion of the Parish Council is that they would not be supportive of actions which would result in Parish boundary changes or would affect the precepting capacity of neighbouring parishes.

# 96/21 Kitswell Park – Dog Fouling (min 61/21)

Councillors were informed that a site meeting had taken place in May with the Neighbourhood Warden to discuss the current problem of dog fouling.

The Neighbourhood Warden has put up signage around the park regarding dog fouling. He has also undertaken a number of patrols during May.

Information on the cleansing schedule of the County Council and the siting of dog waste bins is still awaited.

# 97/21 Car Emissions – Stationary Vehicles (58/21)

Following discussion at a recent Parish Council meeting, information had been sought from the County Council regarding the idling of traffic outside the schools and the impact on air quality.

The legislation that covers vehicle idling can only be used within a declared Air Quality Management Area (AQMA). There is a further requirement to demonstrate that the emissions are significantly contributing to the exceedance of air quality objectives. The County Council are of the opinion that Lanchester would not fulfil the criteria to be declared an AQMA. However the County Council is undertaking actions to improve air quality including visits to schools by a representative of Living Streets. It was agreed that the representative of Living Streets would contact the schools in Lanchester regarding a visit.

## **Resolved that:**

- (i) the information be received
- (ii) an update on the school visits is sought
- (iii) the Head Teachers are asked to pass the message regarding idling of traffic to parents
- (iv) the MP is asked to consider this matter at a national level

## 98/21 Manor Grange Play Area (min 82/21)

Councillors were informed that the grant monies had now been received.

The County Council will undertake the procurement process to secure a contractor to the point of placing the order. The order will then come

from the Parish Council and be in the Parish Councils name. The County Council will undertake the project management role for the project.

The old play equipment was discussed. It was agreed that the removal of the old play equipment should not be included in the tender information. This play equipment will be removed once the new play area has been installed.

## 99/21 Parking and Traffic Speed

Councillors discussed a number of areas of concern including:
