#### 80/22 Solar Planet Walk – Lanchester Valley Walk

A meeting of the working group had taken place on 23 February and the 8 March 2022. Notes from the meetings were presented to Councillors.

Information on the project with the proposed route has been sent to the County Council so that they can begin undertaking some due diligence on the scheme. A project summary has been prepared and provisional prices are being sought to enable funding applications to be prepared. The County Councillors and Parish Councils where the route passes through have been informed of the proposed project. Councillors discussed a S106 fund held by the County Council available for development of open space recreation. It was agreed that this source of funding should be explored for this project.

### 82/22 Beacon – Relocation and the Queen's Platinum Jubilee Beacon event

A planning application has been submitted to the County Council to seek permission to locate the beacon permanently.

With regard to the Beacon event on 2 June 2022 feedback from the Safety Advisory Group is awaited along with confirmation of the licence for the event from the County Council.

### 83/22 Heritage 100 Walk

Each walk will tell a story about the heritage of the area. A walk in Lanchester will be included in this second phase.
