93/22 Police Report

The Police report was considered by Councillors. Councillors considered that there had been a lot of activity recently with thefts and traffic accidents.

Councillors were informed that road traffic collisions (RTC) are recorded under the 'Transport' heading of the police report. If a RTC doesn't require police attendance or the police are not informed, this may not be included in the statistics.

Councillors asked if the CCTV camera on the Village Green was in operation.

Councillors discussed the matter of people without licences going door to door selling items and claiming to be part of a prison reform service. The police would ask residents to stay vigilant and report anything suspicious.

(ii) Memorial Seat

Councillors considered further information on a request for a memorial seat on the Village Green. The suggestion was for a seat to one side of the bus shelter.

Councillors noted that the Parish Council does not own much land. It was agreed that the County Council are asked for advice and whether they have any land options in the Parish.

Councillors were informed that the cricket club are applying for a grant to replace the fencing around the practice nets. They would like a letter of support from the Parish Council to submit with the application.

Councillors considered the proposed parking schemes received from the County Council.

St Bedes School/Howden Bank/Bishops Meadow

The Parish Council would ask that St Bedes School considers their on-site parking and drop off facilities.

The Parish Council would ask for clarification that the proposal does not restrict residents parking in front of their dwellings.
