## 134/22 Solar Planet Walk – Lanchester Valley Walk

A meeting of the working group had taken place on 3 May 2022. Notes from the meeting were presented to Councillors.

Information has been sent to the County Council so they can undertake due diligence on the project. This will include checks confirming land ownership, flood risks as well as consulting with various stakeholders. A project brief has been put together and some provisional prices for the design, manufacture and installation of the sun and planet structures have been gathered.

Meetings to progress funding and design will take place in June and July.

# 135/22 Manor Grange Play Area

Councillors were informed that a pre-start meeting had taken place on 25 April with the play company and the County Council.

The additional seat for the play area has been ordered and the path surface material confirmed. Residents surrounding the play site have received letters informing them of the upcoming works. An article has been submitted to the Village Voice with the plan of the new play area.

The work is confirmed to start this week. The play area has been staked out today with ground works due to be completed this week.

#### 136/22 Beacon – Relocation and the Queen's Platinum Jubilee Beacon event
