#### 5/12 Lanchester Lions Bonfire and Firework Event

The President and two Vice Presidents from Lanchester Lions attended the meeting. Mr Brin Jones, President of the Lions outlined their concerns regarding the recent Bonfire and Firework event.

Although the event had been successful and very well attended with no major incidents, the Lions group were concerned about the following issues:

- The small membership of the Lions to deal with such a big event
- Increased attendance in recent years resulting in the event becoming larger to manage
- The area available on the field for fireworks and the public
- The management of the bonfire
- The traffic issues in the village resulting from such a large event
- People in the crowd using sparklers
- Fireworks being set off in some surrounding houses

It was acknowledged that the event attracts a crowd from a wide area and not just the village.

Brin outlined that they would require 50 volunteers to be able to run the event in future. They intended to approach the cricket club for support and to submit an article to the Village Voice outlining the situation and seeking support.

Members discussed the much valued and successful event. Suggestions of alternative venues, limiting attendance, volunteer support and possible funding avenues were discussed.

It was agreed that the Lions could use Kitswell Park as necessary for the event.

Members stated that if would be preferable for the event to continue but completely understood the restrictions and concerns that the Lions have.

It was agreed to put an article in the next Parish Council newsletter on behalf of the Lions requesting volunteer support.
