92/25 Planning Applications

Developing 33 pitches and access road for holiday units DM/25/00531/FPA

93/25 Decisions of the principal planning authority

The following planning applications have been approved:

- Replacement of existing shop front window and door.
 Improvement and painting to rendered section. Replace existing mortar pointing with lime based mortar.
- Variation of Condition 2 (approved plans) pursuant to planning approval DM/22/01572/RM to alter fenestration.
- T1 Prune to clear Lime tree away from neighbouring house to provide 1.5m clearance and reduce the rest of the tree to balance crown and deadwood.
- Removal of modern and decayed single glazed timber framed windows, replacement with UPVC traditional style flush casement windows.
- Remove and replace all timber windows and doors to dwellings with double glazed UPVC windows.
- A two-storey rear extension, new bay window to the front and front porch.
- Various tree works as per the tree survey provided TPO-DER-076.
- Replacement shopfronts, windows and doors.
- Erection of kiosks and associated works.
- Replacement of 3mp/ windows to rear and installation of 2no. ducts under road to hardstanding in garden.
- Replace timber windows with UPVC
- Various tree works Alderdene House
- Listed Building Consent to create first floor bathroom, removal of fireplace and installation of wood burning stove in lounge, removal of stud partition wall separating hallway and lounge, installation of bathroom window in rear elevation and soil vent pipe in rear roof slope.
- Proposed 3 bedroom detached dormer bungalow dwelling.
- Internal and external works on a listed building.
